# Army chief cites TTP presence, cross-border attacks as only points of contention with Afghanistan

Islamabad(News Desk) Chief of Army Staff (COAS) General Asim Munir has said that the only points of contention between Pakistan and Afghanistan are the presence of the banned militant Tehreek-i-Taliban Pakistan outfit in the latter and cross-border attacks.

The remarks attributed to the army chief were carried by state broadcaster PTV News and were uttered during his Peshawar meeting a day ago with politicians from Khyber Pakhtunkhwa.

Relations between Paki-

been strained due to frequent border skirmishes and Islamabad repeatedly demanding Kabul take action against the TTP for using Afghan soil to launch attacks in Pakistan. Kabul denies the allegations.Last month, at least eight people were killed and 13, including civilians, were injured on the Afghan side during clashes. The two sides were exchanging fire since Pakistani fighter jets bombed alleged TTP camps in Afghanistan's eastern Paktika province.One Frontier Corps soldier was stan and Afghanistan have martyred, while 11 others

were injured in the clashes, which began after a failed bid by militants on the Afghan side to infiltrate Pakistan.Addressing the issue in his talks with politicians, the army chief said Afghanistan was a neighbour "brotherly [and] an Islamic country" with which Pakistan "has always wanted" better relations."The only difference with Afghanistan is the presence of Fitna al-Khawarij in Afghanistan and the spread of terrorism in Pakistan from across the border, and it will remain so until they remove this issue," the army chief was

quoted as saying.In July, the government, through an official notification, designated the TTP as Fitna al Khawarij, while mandating all institutions to use the term khariji (outcast) when referring to the perpetrators of terrorist attacks on Pakistan. The army chief further said: "Our policy is only Pakistan."COAS Munir said that no large-scale operation was being carried out in KP and nor was the TTP active in any area of Pakistan, adding that only targeted operations were carried out based on intelligence.

## Faith in the law has been lost: Bushra

Islamabad(News Desk) Bushra Bibi, the wife of former prime minister and PTI founder Imran Khan, said during a court hearing on Tuesday that her "faith in the law has been lost".She made the remarks while appearing at an anti-terrorism court (ATC) in Islamabad for a hearing related to the Rangers accident case. The case revolves around the death of four personnel of Rangers in an alleged hit-and-run incident on Srinagar Highway during the PTI's Nov 26 protests, with contesting claims made by the government and the party. Last month, the court had directed the police to produce the suspects on Dec 26. Imran, Bushra, Ali Amin Gandapur, Omar Ayub Khan, Sheikh Waqas Akram, Salman Akram Raja, Murad Saeed, Zulfi Bukhari, Hammad Azhar, Raoof Hassan and other PTI leaders have been nominated in the first information report (FIR)."After what happened to the PTI founder Imran Khan and me, my faith in the law has been lost," she said while addressing Judge Tahir Abbas Supra, who presided over the hearing. The case was registered at the Ramna police station under Section 302 (murder), Section 324 (murder attempt) Section 120B (punishment of criminal conspiracy), Section 114 (abettor present when offence is committed), and other sections of the Pakistan Penal Code, Peaceful Assembly and Public Order Act, besides terrorism charges. The FIR alleged that Imran repeatedly issued instructions to the party leadership, his spouse Bushra, Gandapur and his sister Aleema Khan for making all out efforts to get him released from jail and they could "set anything on fire or kill anyone for this purpose".

# May 9 riots: Planners, masterminds to face trial in military court, defence ministry

Islamabad(News Desk) The defence ministry's lawyer, Khawaja Haris, on Tuesday informed the Supreme Court's Constitutional Bench that the alleged masterminds and conspirators of the May 9 "conspiracy" would be

tried in military courts. The bench, including Justices Aminuddin Khan, Naeem Akhtar Afghan, Jamal Khan Mandokhail, Muhammad Ali Mazhar, Hassan Azhar Rizvi, Musarrat Hilali, and Shahid Bilal Hassan, is hearing a case pertaining to the military trials — and recent sentencing — of civilians

for their role in attacks on army installations during the riots that followed ex-premier Imran Khan's arrest on May 9, 2023.

In recent hearings, SC judges have questioned why the accused were "specifically" tried in military courts instead of anti-terrorism courts, with Justice Mandokhail observing that "the executive cannot play the role of judiciary". A day ago, Justice Hila-

li wondered whether the Pakistan Army Act (PAA), 1952, outlined any punishment for officers who suspend the Constitution.

During today's hearing, Advocate Haris, who appeared as the defence ministry's lawyer, in response to a question, said that trials of the conspirators and masterminds would also be held in the military courts.While continuing his arguments from yesterday, the defence ministry lawyer presented Sheikh Liaquat Hussain's case as an example of a civilian being tried in military court.Justice Rizvi asked whether an army officer was tried for their involvement in the events on May 9."How did the people reach the corps commander's house without any weapons," he asked, terming the intrusion a "security failure".In his response, the lawyer said that the charge on the people was for damaging property, adding that no military personnel was tried in the events that unfolded in 2023. However, Justice Mandokhail said that the court wanted to see the circumstances under which a civilian was tried in the Army Act, questioning its jurisdiction."The extent to which you are expanding the scope of the Army Act, [means] anyone can be tried under it," he said.

#### Bilawal touts Sindh's efforts to combat infant mortality

KARACHI: (News Desk) Pakistan Peoples Party chairman Bilawal Bhutto-Zardari on Monday took great pride in the Sindh government's public-private partnership initiatives especially in healthcare sector and lauded its significant achievements in reducing the child mortality rate in the province.

The PPP chief was speaking at a ceremony to mark the release of a report by the Pediatric Acute Lung Injury and Sepsis Investigators (PALISI) network, a US-based health institute, highlighting a significant reduction in child mortality rate at Sindh's public hospitals.

The event was organised by Dow University of Health Sciences at the Dr Ruth Pfau Civil Hospital Karachi.

While Mr Bhutto-Zardari did not speak much on the report during his speech, he took to social media later and shared its key findings. He recalled that the public-private partnership model was first envisioned by former prime minister Benazir Bhutto in the party's 1993 election manifesto, which was now yielding results.

## **Tempers flare during** year's first sitting of parliament

ISLAMABAD: (News Desk) Even though talks between the PTI and government to bring down political temperatures are set to enter their third round, there was no let-up in the acrimony between opposition and government lawmakers in the lower house of parliament on Monday. As the National Assembly met for the first time this calendar year, the session was marred by noisy protests by PTI lawmakers soon after Opposition Leader Omar Ayub finished speaking. At the outset of proceedings, Mr Ayub demanded an independent inquiry commission on the alleged psychological and physical torture of civilians during their trials by military courts. It may be noted that last month, scores of PTI supporters were convicted by military courts for their involvement in the May 9 violence. Mr Ayub also chided government functionaries for their comments on the possible outcome of the Al-Qadir Trust case and claimed that following a deal between the United Kingdom's National Crime Agency (NCA) and a private businessman, the money landed in the Supreme Court's account before being transferred to the national treasury. "What have Imran Khan and Bushra Bibi got to do with it?" he questioned. The PTI also raised alarm over the alleged 'disappearance' of its activists on Nov 26 and sought their immediate recovery.

### 8 terrorists killed in separate KP operations: **ISPR**

The security forces conducted an intelligence-based operation in the Tank District. "After the troops effectively engaged the terrorists at their location, six khwarij were sent to hell", the statement said.

Another encounter took place in the general area of Tirah valley, Khyber District, where the forces "successfully neutralised two terrorists."

KARACHI: (News Desk) Chief Minister Syed Murad Ali Shah on Monday appointed 12 more special assistants, taking their number to 22. The new special assistants were Pir Fazal Shah Jeelani, Liaqat Askani, Tanzila Umme Habiba, Ameer Hamza Rais, Raza Haroon, Khair Muhammad Sheikh, Amanullah Mahsood, Kulsoom Chandio, Muhammad Ali Rashid, Muhammad Ali Bhutto, Hussain Aslam, and Veerji Kolhi. A CM House spokesman said that the newly inducted special assistants would be allocated portfolios shortly by the chief minister.He said that the provincial cabinet was not expanded as the special assistants were not cabinet members. On July 2, 2024, Lal Chand Ukrani, Sardar Faraz Rajar, Qasim Naveed Qamar, Waqar Mehdi, Rajveer Singh, Mansoor Shahani, Usman Hignoro, Abdul Jabbar Khan, Junaid Baloch, and Muhammad Saleem Baloch had been appointed as special assistants to the chief minister. Besides, the provincial government also named eight new spokespersons - Nadir Nabeel Gabol, Sukhdev Asardas, Buland Khan Junejo, Simita Afzal, Tahseen Abidi, Heer Soho, Aqraba Fatima, and Mustafa Abdullah.Now, there are 16 spokespersons for the provincial government as earlier Barrister Murtaza Wahab, Ghanwar Isran Ali, Sukkur Mayor Barrister Arsalan Islam Shaikh, Sarmad Palijo, Abdul Wahid Halepoto, Makhdoom Fakhar Zaman, Muhammad Ali Rashid and Sadia Javed were appointed as spokespersons.

### PTI's Ejaz Chaudhry absent from Senate despite production order Faraz, said.
