Government could have resolved missing persons issue: SC

Islamabad(News Desk) The Supreme Court of Pakistan has expressed frustration over the prolonged issue of missing persons, with Justice Jamal Khan Mandokhail asserting that the government could have resolved the problem had it desired to do so.

The court was hearing a case related to missing persons when additional attorney general informed the court about the government's decision to appoint Justice (retired) Fagir Muhammad Khokhar as the new head of the commission on missing persons, re-

placing Justice (retired) Javed Iqbal, Express News reported.

The attorney general also mentioned that the government intends to establish a tribunal for missing persons through new legislation.

In response, Justice Mu-

hammad Ali Mazhar remarked that such legislation would be necessary to set up the tribunal. The attorney general indicated that the cabinet committee was working on the legislative process and was asking for a timeline to complete it. Justice Mandokhail, however, pointed out that the

law already exists, stating that making someone disappear is a criminal act. He emphasized that if a crime had been committed, a trial should be held, and if no crime had been committed, the person should be released. The court was told that

the government wanted to address the issue of missing persons systematically, but Justice Mandokhail responded, saying that if the government truly wanted to resolve the matter, it would have already been addressed.

Further, Justice Hassan Rizvi questioned how

many missing persons had been recovered by the commission and whether the individuals who had been found were disclosing their whereabouts. The registrar of the missing persons commission explained that those re-

covered do not reveal

where they had been. Justice Masarat Hilali called for new legislation to be enacted specifically for missing persons, and Justice Mandokhail concluded by saying, "We can only hope that the government will resolve the issue. We cannot tell Parliament to legislate on

'Jurisdiction' becomes bone of contention at apex

ISLAMABAD: (News Desk) Contempt proceedings, initiated by the Supreme Court against Additional Registrar (Judicial) Nazar Abbasi over a jurisdictional matter, have evolved into a debate on the primacy of judicial orders versus administrative decisions.

Taking up the contempt case on Tuesday, a two-member regular bench comprising Justice Syed Mansoor Ali Shah and Justice Aqeel Ahmed Abbasi asked why a case regarding the regular benches' jurisdiction was transferred to the constitutional bench.

The bench sought assistance from the attorney general on ramifications for ignoring a judicial order and appointed senior lawyers Munir A. Malik and Hamid Khan as amici curiae. The issue involves 'mismanagement' in the fixing of certain cases that were required to be heard by the constitutional bench, but were 'mistakenly' fixed before the regular bench. Consequently, it led to wastage of time, resources of the institution as well as the parties, according to a Supreme Court announcement. Those cases were fixed before a regular bench comprising Justice Shah, Justice Ayesha A. Malik and Justice Irfan Saadat Khan. The cases were heard on Jan 13, where, in addition to the merits of the case, the constitutionality of a section of the Customs Act were challenged.

May 9 riots: Faisalabad ATC issues non-bailable arrest warrants for PTI's Ayub, Shibli, and others



Islamabad(News Desk) An Anti-Terrorism Court (ATC) in Faisalabad on Wednesday issued non-bailable arrest warrants for PTI leaders Omar Ayub Khan, Shibli Faraz, Kanwal Shouzeb, and former member Fawad Chaudhry in the case of their alleged involvement in the May 9 riots.

The case was registered against PTI leaders and activists for allegedly burning a police van outside the State Bank of Pakistan in the Civil Lines police station area following the brief arrest of PTI founder Imran Khan on May 9, 2023. Earlier this month, the judge had summoned the four leaders for the hearing of the May 9 case, which was registered at Faisalabad's Civil Lines Police Station. However, the leaders had filed a plea, asking for an exemption from the hearing.

Latest Peca changes draft lowers jail term to 3 years, fines remain at Rs2m

Islamabad(News Desk) The latest draft of the proposed changes to the country's cybercrime laws has lowered the prison term in case of violations to three years from seven years while fines remain the same at Rs2 million, it emerged on Wednes-

Last month, Dawn reported that the government was planning 'wholesale' changes to the Prevention of Electronic Crimes Act 2016 (Peca), which would see the formation of a new authority with powers to block online content and

access to social media, as well as prosecute those propagating 'fake news'. State minister for IT and Telecom Shaza Fatima Khawaja had confirmed the plan to "address concerns regarding misinformation", saying that the amendments were under review.As per Dawn's report, the draft amendments proposed to add a new provision, Section 26(A), to Peca, so as to penalise perpetrators of "fake news" online. It stated that any person who "intentionally" posts any information "which he knows or has

reason to believe to be false or fake and likely to cause or create a sense of fear, panic or disorder or unrest" shall be punished with imprisonment which may extend to five years or with a fine which may extend to Rs1m or with both.A later draft proposed a hike to seven years while the fine was raised to Rs2m.The latest draft, seen by Dawn. com today, said: "Whoever intentionally disseminates, publicly exhibits, or transmits any information through any information system, that he knows or has reason to believe to be false or fake and likely to cause or create a sense of fear, panic or disorder or unrest in general public or society shall be punished with imprisonment which may extend upto three years or with fine which may extend to Rs2m or with both."It also proposed the establishment of the Social Media Protection and Regulatory Authority which would perform a range of functions related to social media such as education, awareness, training, regulation, enlistment, blocking and more.

ISLAMABAD: (News Desk) Opposition members from the Pakistan Tehreek-i-Insaf (PTI) continued their noisy protest in the National Assembly on Tuesday during the rare presence of Prime Minister Shehbaz Sharif, as the session saw the lower house passing a bill to establish a health university in the federal capital amid intense sloganeering.Speaker Ayaz

Metropolitan Corporation Islamabad's stray dogs centre struggles to make

ISLAMABAD: (News Desk) A centre set up by the Metropolitan Corporation Islamabad (MCI) to neuter and vaccinate stray dogs is struggling to carry out its daily operations due to a lack of funds and staff, hindering its ability to control the population of stray dogs that has increased significantly.

The Stray Dog Population Centre (SDPC) was established in Tarlai in November 2022 by the MCI on the direction of the Islamabad High Court to control the population of stray dogs through the 'trap, neuter, vaccinate and release' (TNVR) method.

The centre was supposed to neuter and release at least 800 dogs per month. People used to call the helpline and the trained staff were supposed to trap dogs from the said area and shift them to the centre. Initially, this centre performed well, as surgeries were conducted followed by the release of the dogs. However, the performance gradually declined before the completion of its contract on December 7, 2024. Since then, the centre has had no staff or other facilities, including food, for the dogs kept in cages. Similarly, the helpline 1819 set up for citizens to contact the centre for picking up stray dogs is also out of order. "If it is imperative, services of this doctor should be used for neutering the dogs before releasing them," the official said.

Malik Riaz and son should face courts, present their defence: info minister

Lahore(News Desk) Information Minister Attaullah Tarar said on Wednesday that Malik Riaz and his son should "face the courts and present their defence," a day after the National Accountability Bureau (NAB) said the government was reaching out to the United Arab Emirates to seek the business tycoon's extradition in the Al-Qadir Trust

Meanwhile, Riaz termed the NAB's action against him a "new demand for blackmail" and asserted

The development comes on the heels of ex-premier Imran Khan and his spouse's conviction last week in the Al-Qadir Trust case, in which Riaz and his son are also co-accused and proclaimed offenders. As PTI and legal experts pointed to the need for accountability for all those involved, Tarar had said that consultation was ongoing on how to bring the other absconding it was to seek Riaz's extradition, stated it was conducting inquiries and investigations against

him and his associates for "fraud, deceptive practices and cheating the public at large."
