Pakistan 'all set' for 9th Aman multinational exercise: Navy

Islamabad(News Desk) The Pakistan Navy on Sunday announced it was "all set" to host the ninth Aman 2025 multinational naval exercise, which will take place from February 7-11, according to a statement.

The Inter-Services Public Relations (ISPR), which also issued a statement, said that 120 delegations from around the world would attend the first-ever Aman dialogue: a forum running concurrently with the exercise where military leaders will discuss maritime security threats.

"A key feature of this year's exercise will be the Aman Dialogue, where Chiefs

of Naval Forces, heads of Coast Guards, and senior leaders from around the world will convene to discuss regional maritime security and devise joint strategies to counter evolving maritime threats," the Navy's statement read.According to the Navy, 60 countries will participate in the exercise, bringing ships, aircraft and personnel including special forces, marines and explosive ordnance disposal specialists.

The Navy added that the exercise will be divided into harbour and sea phases. "During the harbour phase, activities such as seminars, operational discussions, counter-terrorism demonstrations, and pre-sail planning of evolutions at sea will be held," the Navy statement read."The sea phase would include tactical manoeuvres, exercises related to maritime security such as anti-piracy and counter-terrorism, search and rescue, gunnery firings and air defence exercises." According to the Navy, the sea phase will also include the international fleet review, attended by national and foreign dignitaries.The ISPR mentioned in its statement that the exercise would be "the most prominent and

to participate. The ISPR added, "The opening ceremony of the Aman 2025 exercise will be held at the Pakistan Navy Dockyard. During the Aman exercise, the Pak Marines and the Special Service Group (Navy) will also demonstrate their counter-terrorism skills."Their statement added that joint operations against maritime crimes would also be practiced at sea. "The motto of the Aman series, 'Together for Peace', reflects its core mission, while this year's theme, 'Secure Seas; Prosperous Future, emphasizes the importance of maritime security for global prosperity." the Navy said.

1 dead, 7 injured after explosion near bus travelling from Khuzdar to Rawalpindi: official

Rwalpindi (News Des) At least one person was killed and seven others injured on Sunday when an explosion occurred near a passenger bus travelling from Khuzdar to Rawalpindi, officials said.

"The passenger bus, travelling on the M-8 Highway from Khuzdar to Rawalpindi, was targeted near Khori, some 25 kilometres from Khuzdar City," Khuzdar District Commissioner Yasir Iqbal Dashti told Dawn.com. Among the injured was the bus conductor, said to be in critical condition. The injured were immediately shifted to the Khuzdar Trauma Centre following the blast,

An investigation suggests that an improvised explosive device (IED) was planted in an Alto vehicle parked

A heavy police contingent, Frontier Corps and Levies forces reached the site of the incident and cordoned off the area. An investigation into the incident has begun. While no group immediately claimed responsibility for the blast, the country, particularly Balochistan and Khyber Pakhtunkhwa, have seen a sharp uptick in terrorism-related incidents over the last few months.

Earlier this month, four people were killed and 32 injured in a blast targeting a bus in the suburban area of Balochistan's Turbat.

PTI files plea against 26th Amendment



ISLAMABAD: (News Desk) As an eight-judge constitutional bench, headed by Justice Aminuddin Khan, is set to commence hearing of challenges to the 26th Amendment from Monday, the PTI also instituted a petition seeking court declaration that the amendment violates salient features of the Constitution and affects the judiciary's independence.

Several petitioners, including high court bar associations, requested the Supreme Court to constitute a full court to hear the matter instead of the constitutional bench established under the 26th Amendment. In it petition filed through Advocate Sameer Khosa, the PTI has pleaded that the process by which the amendment was enacted contravenes Articles 63A, 238 and 239 particularly due to the absence of a fully constituted parliament, illegal inclusion of votes of defecting members of parliament and procedural irregularities that undermined the legitimacy of its

30 terrorists killed, 8 hurt in KP operations: ISPR

PESHAWAR / KHYBER: (News Desk) A total of 30 terrorists, including two ringleaders, were killed and eight others injured in separate security operations in Khyber Pakhtunkhwa on Saturday, according to the military's media wing.In a separate development, four police personnel, who had been abducted from South Waziristan Upper three days ago, have been safely recovered. Security forces acting on intelligence effectively engaged the terrorist hideouts in Lakki Marwat, Karak and Khyber districts. A statement issued by the Inter-Services Public Relations (ISPR) read that security forces carried out an intelligence-based operation (IBO) in Lakki Marwat district on the reported presence of terrorists. The forces effectively engaged their location and killed 18 of them while six others were injured during the exchange of fire, it added. Eight other terrorists were gunned down during a security operation in Karak district.

ran Khan has raised multiple objections to the verdict that convicted him in the £190 million corruption case, citing significant procedural flaws, mishandling of evidence and allegations of political victimisation by the National Accountability Bureau (NAB). The appeal calls for his conviction and 14-year sentence to be overturned, emphasising the lack of credible evidence and procedural lapses.Mr Khan's legal team, headed by Barrister Salman Safdar, highlighted critical points in the appeal, including the findings of the UK Court of Appeal's judgement dated Nov 26, 2021. The judgement, delivered by Lady Justice Nicola Davies, Lord Justice Nugee and Lord Justice Snowden, clarified that the funds at the centre of the controversy were neither proceeds of crime nor linked to any illegal activity. The National Crime Agency (NCA) in the UK had agreed to a £190m settlement with property tycoon Malik Riaz Hussain, specifying that the funds would be transferred to Pakistan's Supreme Court account as part of a legal framework, the appeal stated.Mr Khan's appeal accuses NAB of withholding critical evidence and failing to present witnesses from the NCA or relevant documents to substantiate its claims.

Mediation dubbed solution to prolonged litigation, Justice Shah tells LHC Bar

LAHORE: (News Desk) Justice Syed Mansoor Ali Shah, the senior puisne judge of the Supreme Court, on Saturday says the people who are fed up with prolonged litigation can find solution to their problems at the Alternate Dispute Resolution (ADR) system.

"Arbitration and mediation should be encouraged as adopting such systems has become essential," he asserted speaking at a conference on ADR organised at the Lahore High Court Bar Association.

Justice Shah said with the new ADR law, the traditional courts would step aside and alternative methods would have to be adopted to resolve the people's issues. He highlighted that there were currently only 13 judges for a million people, which showed the judges shortage and the challenges inherent in the judicial system. Justice Shah stressed the need to abandon old practices, saying important cases were delayed due to the sheer volume of cases, pointing out that in 2023, 1.7 million cases were decided by the courts across Pakistan yet many remained pending. He said the alternative pathways must be created for litigants and expressed regret that the delays in case resolutions were often caused by lawyers and systemic issues like strikes. Justice Shah suggested giving litigants the right to initially opt for mediation. He highlighted the significant differences between the judicial and mediation systems, stating that mediation would reduce costs and resolve more issues. He assured the lawyers that the ADR system would not create financial problems for them.

Islamabad(News Desk) Senator Saleem Mandviwalla, highlighting numerous reservations of the PPP, has warned that the ruling PML-N would face the "biggest loss" if his party breaks off its alliance with the govern-

The differences between the PML-N-led coalition government and its key ally PPP have been simmering for a while. A meeting last month between Prime Minister Shehbaz Sharif and President Asif Ali Zardari to revive trust seemingly

failed to put an end to these disagreements.

During an interview with DawnNewsTV programme 'Doosra Rukh', aired on Saturday, Senator Mandviwalla claimed that Deputy Prime Minister Ishaq Dar has realised if the coalition breaks, PML-N will suffer the greatest loss.

Highlighting Deputy PM Dar's efforts to find solutions to the issues between the two coalition allies, the senator said Dar was the "only one making efforts to bring the parties to a table. No one else does this."

Mandviwalla highlighted that the Prime Minister's Office was not implementing directives issued by the President House. When asked if President Zardari was unhappy with the situation, he responded: "Of course, of course. "If a directive is sent by the president of Pakistan [...] and it's not implemented, then what will happen at lower levels?" he asked. The PPP lawmaker's statements come days after a meeting of PPP's Central Executive Committee

(CEC) was held, amid the

party's reservations that the government did not take it on board in decision-making and backed out of its promises made to the party.

At the meeting, the PPP had demanded that the federal government hold local government polls in Punjab and Islamabad as per the agreement between the PPP and the government.
