Peshawar(News Desk) Khyber Pakhtunkhwa Governor Faisal Karim Kundi on Sunday said Chief Minister Ali Amin Gandapur was trying to "erase the province's identity" as he criticised the renaming of a stadium in Peshawar to Imran Khan Cricket Stadium.

His statements come after the KP cabinet on Friday approved renaming the Arbab Niaz Cricket Stadium — the lone international cricketing venue in the province — to Imran Khan Cricket Stadium.

The KP government had decided to honour former

prime minister Imran's "remarkable contributions to Pakistan's cricketing legacy and his pivotal role in shaping the nation's sports landscape".

In his statement, Governor Kundi termed the stadium's name change "extremely inappropriate". He accused CM Gandapur of being on a mission to "erase the province's identity".The KP governor further claimed that naming the stadium after the "mastermind" of the May 9, 2023 riots "strengthens anti-state elements".

The stadium, according to a summary by the KP sports department presented before the provincial cabinet, was transferred to the sports board from the municipal corporation and the provincial government undertook its development in 1986-87.

## Pattan says its offices sealed for 'exposing poll rigging'

ISLAMABAD: (News Desk) Pattan Development Organisation has said that the house of its chief and its office in Multan have been sealed by authorities in retribution for its report exposing alleged rigging in last year's general election. The properties have been

sealed on the orders of the Ministry of Interior, the organisation claimed. The organisation said it does not have any office in Islamabad, as all staff work from home. The address of the house of Pattan's national coordinator, Sarwar Bari, in the

capita is used for correspondence and is mentioned on the organisation's website.

A Pattan spokesperson said that around two dozen police officials, along with a magistrate, entered the house located in Sector F-10, Islamabad on Friday night and sealed it.

RetributionEarlier this month, Pattan had published a report on the general elections and described them in a statement as "unprecedentedly rigged" with "vote-rigging, fraud and manipulation". The spokesperson claimed the action was retribution for the report. In Multan, a notice has been placed at the gate of Pattan's office. The order, issued by Registrar Joint Stock Companies, Multan, stated that the action was taken on the Ministry of Interior's letter dated Feb 18. The letter stated that Pat-

tan was dissolved in Nov 2019, and the NGO "did not challenge" the order in any court. The Pattan spokesperson has said that the NGO never received any notice from the registration au-

thority about its dissolution.

He added that the Election Commission of Pakistan had issued accreditation to Pattan's election observers, the spokesperson said, adding that all records can be presented to the media.

"Our bank accounts [remained] functional and we even paid taxes to FBR."

The Human Rights Commission of Pakistan criticised the authorities' action against Pattan and said it was a violation of Article 14(1) of the Constitution.

#### Afghans denied US resettlement to be deported

ISLAMABAD: (News Desk) Pakistan on Saturday warned that Afghan refugees not accepted for resettlement by the United States would be treated as illegal immigrants and deported.

Deputy Prime Minister and Foreign Minister Ishaq Dar, in an interview with TRT details of which were shared by the FO on Saturday, said that while Pakistan was open to negotiations with the US on the matter, refugees whose resettlement is denied would face deportation. "We will be examining the issue and will negotiate,"

Mr Dar said. "However, in principle, if any refugee was meant to be taken by another country after due process — no matter the timeline — and if it doesn't happen and the country refuses, that person will be considered an illegal immigrant in Pakistan."

ISLAMABAD: (News Desk) Pakistan has reported another case of wild poliovirus type 1 (WPV1), taking the total to three cases in 2025.

According to an official of the Regional Reference Laboratory for Polio Eradication, the case has been reported from Larkana, Sindh.

The official said that the victim is a 54-month-old girl. This is the second polio case reported from Sindh this year, with the third one detected in Khyber Pakhtunkhwa.

Pakistan is facing a resurgence of poliovirus, as 74 cases were reported in 2024.

f these, 27 were from Balochistan, 22 from KP, 23 from Sindh, and one each from Punjab and Islamabad. This year's first nationwide polio vaccination campaign

was held earlier this month.

It was followed by a fractional IPV-OPV Polio [injectable polio vaccine] campaign in Quetta and Karachi on Feb 20 and 22, respectively. Around one million children were targeted for vaccination in this campaign, according to the officials. Moreover, a vaccination campaign in 104 union councils bordering Afghanistan or having Afghan refugee camps is scheduled from Feb 24 to 28.

Earlier this week, five sitting judges of the IHC had petitioned the top court against recent changes to the high court following the transfer of new judges from different provinces. The friction among IHC judges started earlier this month when Lahore High Court's Justice Sardar Muhammad Sarfraz Dogar, Sindh High Court's Justice Khadim Hussain Soomro and Balochistan High Court's Justice Muhammad Asif were transferred to the IHC. The legal fraternity protested the move and accused the government of undermining the court's independence.What further irked the sitting high court judges and lawyers was the controversial revision of the court's seniority list, which saw Justice Dogar become the senior puisne judge in place of Justice Mohsin Akhtar Kayani.Justice Dogar was subsequently appointed the acting chief justice after the incumbent, Justice Aamer Farooq, was elevated to the Supreme Court.

The protesters announced that they would not allow the government to complete the dam until their 31-point charter of demands was met. The first meeting of the committee, constituted by Prime Minister Shehbaz Sharif recently to address the grievances of the affected people, was held in Islamabad on Saturday with Minister for Kashmir Affairs and Gilgit-Baltistan Amir Muqam in the chair. # IHC upholds Auditor General of Pakistan's exclusive power to conduct audits

ISLAMABAD: (News Desk) The Islamabad High Court, in a significant ruling aimed at strengthening financial oversight and accountability in the public sector, has upheld the constitutional authority of the Auditor General of Pakistan, reaffirming AGP's exclusive power to conduct audits of all entities utilising public funds under Article 170(2). No statutory law or government directive can restrict AGP's mandate, court rules

The court held that the government, including ministries and other public sector organisations, could not limit or interfere with AGP's constitutional functions. The judgement outlined that while government departments could establish their internal audit mech



anisms, the same could not replace or override AGP's independent authority.It stressed that AGP's role extended be yond routine financial checks, as it ensured adherence to international audit standards and constitutional provisions.
