Bilawal sees Pakistan as 'bridge builder' between China and US

Islamabad(News Desk) PPP Chairman and former foreign minister Bilawal Bhutto-Zardari has said that Pakistan can be the bridge between China and the United States, Deutsche Welle (DW) reported on Monday. Speaking at the Munich Security Conference, Bilawal discussed the country's engagement with China and the US, expectations from President Donald Trump, improving relations with India, and security challenges.

'The pace of that competitiveness [between China and the US] has very palpable effects all across the world [...] From a Pakistani perspective, historically, we have played the role of bridge builder rather than a dividing force," he said. He added, "If you want to put us in a camp, we would like to see ourselves as bridge builders. We played that role in the past between establishing diplomatic contacts and the relationship between the US and China. "Going forward, we would like to see ourselves as a country that can bridge that gap rather than increase that division."When asked about the new Trump administration, Bilawal called Trump a "deal maker" and said, "Given the challenges we face in the region.

5.1-magnitude quake jolts Swat, surrounding areas



Swat (News Desk) A 5.1 magnitude earthquake was felt in Khyber Pakhtunkhwa's Swat and its surrounding areas on Tuesday.

The epicentre was located at the border area of Pakistan, Afghanistan and Tajikistan, the Associated Press of Pakistan reported, citing the Seismological Centre.

No casualties or property damage have been re-

The tremors caused panic among the residents, who rushed out of their homes and began reciting

The tremor comes just days after a 4.8 magnitude earthquake was felt in the twin cities of Rawalpindi and Islamabad on Saturday. No casualties were reported.

In December last year, tremors were felt in various cities of KP as well as Islamabad after a quake jolted Afghanistan's Badakhshan region.

Earlier in September, tremors from a 4.5-magnitude earthquake were felt in Swat and its surrounding areas, causing panic among residents. The earthquake's depth was recorded at 151 kilometres, with its epicentre located in the Hindu Kush Mountain range, a seismically active area known for frequent quakes.

ATC grants police main suspect's 4-day remand in Mustafa Amir murder case

Islamabad(News Desk) An anti-terrorism court in Karachi on Tuesday granted the police a fourday physical remand of Armaghan, the main suspect in the Mustafa Amir murder case, following the Sindh High Court's (SHC)

Earlier today, the SHC set aside previous ATC orders for his judicial remand and to form a probe body.

Amir, a 23-year-old, was kidnapped and allegedly murdered by his friends in Karachi's Defence Housing Authority (DHA) on January 6. According to the police, the youth's friends stuffed his body

in the trunk of his car and torched it in the Hub area of Balochistan.

Earlier this month, police arrested Armaghan for injuring policemen in an attempt to resist his detention in connection with Amir's kidnapping case. Another suspect, Armaghan's friend Sheraz aka Shavez Bukhari, was remanded in police custody by an antiterrorism court (ATC) last week.

Sindh Acting Prosecutor-General Muntazir Mehdi, on behalf of the Sindh government, had filed revision applications in the SHC, challenging the ATC orders denying the police

Armaghan's physical custody and sending him on judicial remand instead. Another application was also filed against an ATC order on the suspect's father plea against a raid at his residence.

After issuing notices to the respondents yesterday on four revision pleas, a two-member SHC bench headed by Justice Zafar Ahmed Rajput resumed the hearing today.

Armaghan, stated to be in his early twenties, was presented before the court as per the bench's orders from yesterday. His father, Kamran Qureshi, was also present in the court and brought fruits for his son, alleging that the latter had been tortured during his detention.

Mehdi, Additional Prosecutor-General (APG) Muhammad Iqbal Awan, current Investigation Officer (IO) Inspector Muhammad Ali and previous IO Ameer Ashfaq also appeared before the bench, along with other policemen.During the hearing, Mehdi, APG Awan and IO Ashfaq presented their contentions before the judges. The additional prosecutor-general sought Armaghan's physical custody for further investiga-

PTI wants courts to expedite 26th amendment, rigging

ISLAMABAD: (News Desk) Leaders of the opposition PTI on Monday urged the judiciary to expedite the cases related to alleged rigging during the general elections and the 26th Amendment, expressing concern that the matters remained undecided despite the passage of a yearThe demand was reiterated by PTI Chairman Barrister Gohar Ali Khan, Leader of the Opposition in the National Assembly Omar Ayub, Senator Shibli Faraz and the party's General Secretary Salman Akram Raja at a press conference, held at Khyber Pakhtunkhwa House in the capital. Barrister Gohar claimed the party had filed 74 petitions regarding alleged rigging in the Feb 8, 2024 elections, but the courts had failed to deliver any verdicts. He also criticised the 26th Amendment, passed

IHC restructuring strips

Court has undergone a major administrative restructuring, which has notably reduced the authority of senior puisne judge Justice Mohsin Akhtar Kayani who previously held key decision-making roles — following recent amendments to the high court rules. The changes followed the transfer of three judges from different high courts to the IHC and the subsequent reconstitution of the Administration Committee.Justice Sardar Mohammad Sarfraz Dogar was appointed IHC's acting chief justice, leading to a reshuffle within the court's administrative framework. The move triggered objections from senior judges, who argue that it undermines judicial seniority and due process. The IHC Administration Committee, previously comprising the chief justice, the senior puisne judge and a senior judge, has now been restructured to include Chief Justice Dogar and two of his nominees. This reconstitution significantly alters the court's decision-making authority. Amendments to rules grant CJ discretion in committee appointmentsThe changes were formalised through amendments to Rule 237, Chapter 10 of the High Court Rules. Fazl slams govt over 'lack of civilian decisionmaking'

Rehman on Monday launched a blistering attack on the government's handling of national security issues and warned that the country's very existence was under threat due to lack of civilian decision-making. Speaking on a point of order in the National Assembly after the house hurriedly passed five bills aimed at curbing human trafficking and organised beggary amid noisy opposition's protest, the JUI-F chief cautioned that "Pakistan's physical boundaries might be altered sooner rather than later" unless drastic measures were taken to address pressing concerns, including the lack of state writ in the provinces of Balochistan and KP as well as the newly-merged tribal districts. There was a stunned silence during the Mr Rehman's speech, and a few instances when the opposition members shouted 'shame, shame'. PTI members, who had made two failed attempts to disrupt the proceedings by pointing out quorum and raised slogans during the passage of the bills, later heard the Mr Rehman's speech in complete silence. However, as soon as Law Minister Azam Nazeer Tarar took the floor to respond to Mr Rehman's speech, the PTI members once again started sloganeering and one of its members pointed out quorum for the third time. Deputy Speaker Ghulam Mustafa Shah adjourned the sitting till Tuesday morning (today) after declaring the house not in order due to a lack of quorum, for which the presence of 84 members is required in the 336-member house.

Supreme Court sees shake up after entry of new judges

ISLAMABAD: (News Desk) After the arrival of new Supreme Court judges, Chief Justice of Pakistan (CJP) Yahya Afridi on Monday reshuffled a number of committees which had been constituted to distribute different responsibilities among judges of the top court.

CIP Afridi through an office order reconstituted the six-member 'Case Management Committee' headed by himself and comprising Justice Naeem Akhtar Afghan, Justice Shahid Bilal Hassan, Justice Muhammad Shafi Siddiqui, the additional registrar (judicial). The IT director will be its secretary. The committee will ensure efficiency in judicial work by streamlining case management.

The CJP also appointed five judges of the Supreme Court to supervise and monitor the functions and performance of special courts (anti-terrorism courts) in Pakistan. Justice Musarrat Hilali will act as the monitoring judge for ATCs in Khyber Pakhtunkhwa (KP) while Justice Malik Shahzad Ahmad Khan, Justice Hashim Khan Kakar, and Justice Salahuddin Panhwar will act as monitoring judges in Punjab, Balochistan, and Sindh. Justice Aamer Farooq will be the monitoring judge for Islamabad special courts.

The CJP also tasked a committee comprising Justice Malik Shahzad Ahmad, Justice Hashim Kakar, Justice Salahuddin Panhwar, and Justice Ishtiaq Ibrahim with monitoring of model courts. The SC's IT affairs committee was reshuffled, with the CJP being its chairman, and Justice Muhammad Ali Mazhar and Justice Miangul Hassan Aurangzeb its members.

Bulls dominate as PSX rises by nearly 1,400 points with experts citing 'good corporate results'

Islamabad (News reciprocal tariffs im-Desk) Bulls dominated the trading floor on Tuesday at the Pakistan Stock Exchange (PSX) as shares rose by nearly 1,400 points, with experts citing "good corporate results" as the reason for the uplift.

The rise comes after the market sustained a three-week losing streak, despite bearish performances in the last three sessions due to political noise and

posed by US President Donald Trump on American allies and competitors, which heightened concerns about a potential global trade war.

After the slump, shares at the exchange went on a record-setting streak as the KSE-100 index climbed more than 3,000 points to surpass the 114,000

The market opened last week with a specState Bank of Pakistan data, showing a surge of over a quarter to \$3 billion in January. The benchmark KSE-

100 index climbed 1455.85 points to stand at 345,519,481 points from the previous close of 111,743.53 points at 3:30pm.

Finally, the index closed at 113,088.47, up by 1344.94 points or 1.2pc, from the previous close.
