## Pakistan, China agree to enhance intelligence sharing in meeting of security czars

Islamabad(News Desk) Pakistan and agreed to further improve mutual intelligence sharing in a meeting between their interior ministers on Wednesday.

The development came in a meeting between Interior Minister Mohsin Naqvi and his Chinese counterpart Qi Yanjun during the former's visit to Beijing. Naqvi is part of a delegation led by President Asif Ali Zardari that landed in China a day ago and also includes Deputy Prime Minister and Foreign Minister Ishaq Dar, Senator Saleem Mandviwala, and Dr Asim Hussain. The interaction between

Naqvi and his Chinese counterpart lasted two hours and came in the backdrop of attacks on Chinese personnel working in Pakistan that have angered China, which has pushed the federal government to begin formal negotiations for a joint security management system. Pakistan's ongoing counter-terrorism efforts remain a key topic of discussion between the two countries due to the rising frequency of attacks targeting Chinese nationals working in Pakistan.

Of the major attacks that have targeted Chinese citizens in Pakistan since 2021, the biggest one was

when at least 12 persons, including nine Chinese engineers and two Frontier Corps personnel, were killed when a bus was attacked near the Dasu hydropower plant in KP's Upper Kohistan district in

Aside from vowing to enhance intelligence sharing between the two nations, the interior ministers also discussed cooperation to further secure the border between the two countries, in addition to the use of modern technology for police and paramilitary

The two officials also led a detailed discussion on acquiring modern equipment and technology for the police from China. Cooperation with the National Police Academy was also discussed by the two officials who further decided to increase cooperation between the Beijing Police and Islamabad Police. They also expressed satisfaction over a meeting of the Joint Working Group in January in which the two sides had reaffirmed their commitment to high-quality development of the second phase of the China-Pakistan Economic Corridor (CPEC) with an emphasis on industrialisation, special economic zones, clean



#### UNHCR, IOM concerned about plan to move Afghan refugees

Islamabad(News Desk) The United Nations Refugee Agency (UNHCR) and the International Organisation for Migration (IOM) on Wednesday expressed concern over the government's "devised plan" to move registered Afghan refugees out of Islamabad and Rawalpindi, seeking clarity from the government over the "modality and timeframe" of relocation. The government has devised a plan to move registered Afghan refugees out of Islamabad and Rawalpindi and gradually repatriate them back to their country, sources with knowledge of the plan told Dawn. Authorities have also been directed to implement the plan without making any public announcement in this regard. Under phase I of the relocation plan, Afghan nationals having the Afghan Citizens Card (ACC) will be "immediately" moved out of Islamabad and Rawalpindi. They will then be sent back to Afghanistan alongside illegal and undocumented refugees. According to a joint statement issued in Islamabad today, both organisations recognised that the state chose to limit freedom of movement for foreigners, including refugees, however, they urged the government to "implement any relocation measures with due consideration for human rights standards.

#### Challenges to Peca land in Supreme Court, SHC



ISLAMABAD/KARACHI: (News Desk) Days after their promulgation, the amendments to the Prevention of Electronic Crimes Act (Peca) faced separate challenges in the Supreme Court and the Sindh High Court for posing a threat to press freedom and fundamental

The petition filed in the Supreme Court by Muhammad Qayum, a resident of Ghizer in Gilgit-Baltistan, sought a full court review of the recent changes, saying that Peca tweaks were against the Constitution, beyond the power of the legislature and extremely repugnant to the human rights, fundamental rights and freedom of expression and speech.

The petitioner urged the court to strike down the law after a judicial review by the full court. He argued that in the national interest to maintain peace and stability both the amendment as well as the existing law should be reviewed. The petition alleged that the law was introduced to target opponents and therefore these could not be sustained and must be restricted. The petition also stated that until the final adjudication of the case, the law may be suspended by the court.

### PM Shehbaz, President Zardari urge global action as country observes Kashmir Solidarity Day

Islamabad(News Desk) President Asif Ali Zardari and Prime Minister Shehbaz Sharif have urged the international community to put pressure on India to allow the Kashmiri people to freely determine their own future for lasting peace in the region, state-run Radio Pakistan reported.

In his message on Kashmir Solidarity Day being observed today (Wednes-day), PM Shehbaz highlighted that a lasting peace could not be achieved by suppressing the genuine aspirations of the local

in the Middle East amply showed that long-standing disputes should not be allowed to fester, the Associated Press of Pakistan (APP) quoted the premier as saying in a statement. He said the government and the people of Pakistan annually observed the

Kashmir Solidarity Day to renew their steadfast support for the Kashmiri people's just and legitimate struggle for the realisation of their right to self-deter-"The right to self-determi-

nation is a fundamental principle of international law. Every year, the UN General Assembly adopts a resolution that stresses the legal right of people to decide their own destiny," the premier said, according to a statement from his office."Regrettably, despite 78 years having passed, the Kashmiri people have yet to exercise this inalienable right," he lamented.

"Today, the Indian Illegally Occupied Jammu and Kashmir (IIOJK) remains one of the most militarised zones in the world. Kashmiris are living in an environment of fear and intimidation," PM Shehbaz highlighted.

Reiterating that the Jammu and Kashmir dispute would remain a key pillar

of Pakistan's foreign policy, the premier reaffirmed the country's "unwavering moral, diplomatic and political support to the Kashmiri people till the realisation of their right self-determination". President Asif Ali Zadari said the day reminded the global community of its responsibility towards the oppressed Kashmiri people, according to Radio Pakistan.The president stated that the United Nations should honour the promises made to the Kashmiris 78 years ago and support their struggle for their right to self-determination.

# NAB restrained from arresting Qaim Ali Shah, Sharjeel in Bahria Town Karachi land grab case

KARACHI: (News DEsk) The Sindh High Court on Tuesday restrained the National Accountability Bureau (NAB) from arresting two Pakistan Peoples Party leaders, former chief minister Syed Qaim Ali Shah and senior Sindh minister Sharjeel Memon, in the Bahria Town Karachi land grab reference.

Mr Shah and Mr Memon filed petitions before the SHC and challenged the jurisdiction and summons issued by an accountability court after NAB filed

two-judge constitutional bench comprising Justice Mohammad Karim Khan Agha and Justice Adnan-Ul-Karim Memon also suspended the summons issued by the accountability court and asked the petitioners to furnish solvent surety of Rs100,000 each.

The commander Pakistan Fleet highlighted that with the evolving global landscape shift from geopolitics to geo-economics, the security of global sea-borne trade and energy routes has gained unprecedented importance. The Indian Ocean Region faces a range of challenges, from traditional security threats to non-traditional risks. These issues have broadened the scope of maritime security, compelling nations to re-evaluate their strategies and policies. "Here no single country can address the complex challenges at sea alone. Therefore, we are 'together for peace"."The primary objective of this exercise is to bring the maritime nations together to adopt safe and sustainable procedures, share experiences and collectively address maritime threats," he said. The Aman Exercise is divided into two phases: harbour and sea. The harbour phase, to go on from February 7 to 9, will include seminars, operational discussions, professional demonstrations, international gatherings and sports fixtures.
