Jaffar Express hijacking: State media 'reports 190 rescued, 2nd day of operation underway in Balochistan

Balochistan(News Desk) Security forces have rescued at least 190 passengers and killed 30 terrorists as a rescue operation continues into its second dav after terrorists hijacked the Jaffer Express train near Balochistan's Bolan district, state media said on Wednesday. The unprecedented hos-

tage situation began on Tuesday near the Mashkaf Tunnel, about 157 kilometres from Quetta, when terrorists attacked the Jaffer Express and took more than 400 passengers hostage, including numerous security personnel. What we know so far:

The report further said 37 injured had been sent for medical treatment.

"The terrorists responsible for the cowardly attack on Jaffar Express are in contact with their facilitators in Afghanistan," Radio Pakistan further said."The terrorists have positioned suicide bombers very close to some innocent hostages. The suicide bombers are wearing explosive vests," the report quoted security sources as saying.

Sehwan high school caught in crossfire

Sehwan(News Desk) Panic gripped Sehwan city when an armed group of people attacked a government boys high school on Wednesday, according to police.

Hyderabad Deputy Inspector General (DIG) of Police Tariq Dharejo confirmed to Dawn that two groups of the Rind community were involved in some dispute, and one of them resorted to firing on the school to settle their score with rivals. He said no casualty was so far reported."They attacked a teacher, Pir Mohammad Rind, but he remained unhurt. His motorbike was damaged, and the attackers fled away," DIG Dharejo added.

Jamshoro Senior Superintendent of Police (SSP) Zafar Siddiqui reached the scene, and police from Dadu also arrived there.In December of last year, 14 people had suffered wounds when rival groups of the Pararo community armed with sticks and iron rods clashed with each other over a land dispute in the Kachi Abadi area, Sehwan town.DIG Dharejo said that according to the latest reports, the firing was the result of a land dispute amongst the Rind community.

Legality of super tax comes under SC **Constitutional Bench scrutiny**

ISLAMABAD: (News Desk) The Constitutional Bench of the Supreme Court, hearing a set of challenges to the imposition of super tax, was informed on Tuesday that the cess was initially introduced as a one-time measure for a specific purpose in 2015 but continued to be enforced until 2022.

The judge emphasised that the rehabilitation of affected areas was a local or provincial matter, raising concerns about using national funds without

provincial consent. He also questioned whether taxes on services could be implemented through a money bill.

Justice Muhammad Ali Mazhar questioned the indefinite continuation of the super tax, asking whether a tax, once imposed, could last forever. The counsel argued that the recovery and expenditure of the super tax were never mentioned in any speeches by the finance minister and that the government should be asked to disclose how much tax had been collected and spent.

Dera court orders exhumation of body of Vani girl's father

DERA ISMAIL KHAN: (News Desk) The district and sessions judge here on Tuesday ordered the exhumation of the body of a man for postmortem after his alleged death by suicide following a Vani decision by a panchayat about his daughter.DSJ Syed Anees Badshah announced the verdict following a request by the prosecution branch, after which the judicial magistrate of Paharpur was directed to complete the exhumation and postmortem process. In its petition, the prosecution branch stated that it was crucial to determine the actual circumstances surrounding Adil's death. The court accepted the request and issued orders for the exhumation and medical examination to uncover the real causes behind his demise. Additionally, the Paharpur police have formally requested a forensic analysis of the audio message that Adil allegedly recorded.

ISLAMABAD: (News Desk) The opposition in the Senate on Tuesday challenged the legality of legislation passed by an incomplete parliament, raising concerns over constitutional violations and procedural irregularities.

Speaking on a point of order on the last day of the Senate's parliamentary year, Leader of the Opposition Syed Shibli Faraz criticised what he called a series of constitutional defiance that had created legal complications and controversies.

Mr Faraz pointed out that under Article 59 of the Constitution, the Senate must consist of 96 members, each serving a six-year term. However, the house had remained incomplete for over a year due to the non-holding of Senate elections for 11 seats from Khyber Pakhtunkhwa.

"The house is incomplete, yet key legislative actions, including the election of the Senate chairman and deputy chairman, have been carried out. How can these elections be valid when the house itself is not duly constituted?" he questioned.Reading Article 60, he said that "the term of the office of the chairman or deputy chairman shall be three years from the day on which he enters in his office".

PAC questions award of Rs1.8bn contract to NLC by NDMA sans bidding

ISLAMABAD: (News Desk) The controversial award of a Rs1.89 billion contract by the National Disaster Management Authority (NDMA) directly to the National Logistics Cell (NLC) for constructing the National Emergency Operations Centre came under detailed discussion during the Public Accounts Committee (PAC) meeting on Tuesday.

Questions were raised by the Public Accounts Committee (PAC), chaired by Junaid Akbar Khan, about the transparency of the bidding process, as only military-affiliated institutions were considered.

The PAC was convened to review audit reports of the NDMA and the Ministry of Communications. Discussions centered on the financial and operational aspects of disaster management and relief efforts in the country. The Auditor General of Pakistan's office noted that during the financial year 2022-23, bid invitations were extended to three military-affiliated entities - the National Logistics Cell (NLC), Frontier Works Organisation (FWO), and Railcop. However, only NLC submitted a bid, which was subsequently accepted, leading to a single-bid contract award. The audit report highlighted that no mechanism was in place to assess price reasonability, raising concerns over compliance with public procurement rules. It also questioned why only military-affiliated organisations were deemed suitable for development projects in the country.
