# PM Shehbaz departs for two-day official visit to Belarus

Islamabad(News Desk) Prime Minister Shehbaz Sharif departed on Thursday departed for a two-day official visit to the Republic of Belarus at the invitation of President Aleksandr Lukashenko.

He was accompanied by a high-level delegation comprising Deputy Prime Minister and Foreign Minister Ishaq Dar, Punjab Chief Minister Maryam Nawaz, Information and Broadcasting Minister Attaullah Tarar and Special Assistant to the Prime Minister Tariq Fatemi

During his visit from April 10-11, the prime minister will hold talks with Pres-

ident Lukashenko to review progress in areas of mutual interest."Over the past six months, a series of high-level bilateral engagements —including the 8th Session of the Joint Ministerial Commission (JMC) in February 2025 and a subsequent visit by a high-powered mixed ministerial delegation to Belarus in April 2025 have laid the groundwork for a productive visit," the Foreign Office said in a statement today."The two sides are expected to sign several agreements to further strengthen cooperation."The Prime Minister's visit underscores the strong and ongoing

partnership between Pa-kistan and Belarus," the FO said.In November last year, Pakistan and Belarus signed a three-year, wide-ranging 'Roadmap for Comprehensive Cooperation' agreement, aimed at strengthening economic ties between the two countries.The Roadmap for Comprehensive Cooperation between Pakistan and Belarus for 2025-27, described by the Pakistani government as a "key outcome" of the visit, was among 15 Memorandums of Understanding (MoUs) and agreements signed during talks between PM Shehbaz and the Belarusian president. ## Indus drying up before our eyes, says Sherry

ISLAMABAD: (News Desk) Senator Sherry Rehman on Wednesday expressed concern over unprecedented water crisis in the Indus River system which is experiencing a historic 100-year low.In an urgent call to action, the former climate change minister stressed that the situation is now a national emergency and it must not be politicised."The Indus River is drying up before our eyes," warned Senator Rehman, who heads the Senate Standing Committee on Climate Change and Environmental Coordination."Rainfall has dropped by 40pc due to accelerating climate change. The Sukkur Barrage is experiencing a 71pc decline in water levels, while overall shortages across all three barrages have reached 65pc. These are staggering numbers," she said. Ms Rehman criticised the current response to the crisis, pointing out that instead of conserving the rapidly depleting water resources, canal extractions were being carried out which is further draining the Indus water.

#### AGP seeks time to answer whether May 9 convicts can move other courts

ISLAMABAD: (News Desk) Attorney General for Pakistan (AGP) Mansoor Usman Awan on Wednesday requested the Supreme Court's constitutional bench — hearing cases related to the military trial of civilians - to propose any additional conditions for judicial review under the Pakistan Army Act, 1952, beyond those established in the 2015 Rawalpindi District Bar Association case. Though the AGP sought time to consult the government on a key question raised by the seven-judge bench — whether convicts in the May 9 attacks should have the right to appeal before an independent court - he affirmed that the bench could suggest further conditions for judicial oversight. Headed by Justice Aminuddin Khan, the CB had taken up 38 intra-court appeals moved by the governments as well as the Shuhada Forum Balochistan against the Oct 23, 2023 judgement. While deciding challenges to the 21st Amendment under which nine special courts manned by military officers were set up, the SC in 2015 held that any sentence awarded in such trials will subject to judicial review on the grounds of coram non judice.

ISLAMABAD: (News Desk) The Election Commission of Pakistan (ECP) on Wednesday urged the Supreme Court to reject petitions seeking right to vote for overseas Pakistanis by challenging an amendment to Section 94 of the Elections Act, 2017.

The request has been moved on behalf of ECP Secretary Omar Hamid Khan highlighting that the overseas Pakistanis' right to vote was very much recognised and the ECP was working tirelessly to extend this right, but a blanket and unqualified right cannot be claimed. There is no denial of the right in question as it was merely subject to regulation and modalities which need to be fixed by the law, the ECP pleaded, adding that obligations being proposed through the petitions cannot be imposed on the state when no violation of any fundamental right has been made out.

Several petitions are pending before the court challenging amendments to the Elections Act 2017 filed by PTI founder Imran Khan, Sheikh Rashid Ahmed and others.

On Aug 24, 2022, the apex court had ordered removing objections raised by the registrar office with an observation that the Pakistani expatriates should be extended facilities on a priority basis since they contribute around \$30 billion of badly needed foreign exchange to the country.

## 10,000 women in Pakistan die of complications during pregnancy every year: health minister

ISLAMABAD: (News Desk) Health Minister Mustafa Kamal on Wednesday said every year 10,000 women in Pakistan lose their lives due to complications during pregnancy.

He revealed these figures while speaking at an event held in connection with World Health Day in the office of World Health Organisation (WHO).

These are silent tragedies happening across the country, with little to no public outcry," the minister said, adding that "if such a high number of deaths occurred due to any other cause, our national response would be very different. We cannot afford to lose even a single life due to maternal causes."

He stressed the urgent need for both individual and collective efforts to prevent these avoidable deaths, saying, "every life is precious and must be protected. These women can be saved."

Highlighting the weaknesses of the healthcare system, Mustafa Kamal said: "Pakistan's health system is not in a healthy state. But we are hopeful with systemic reforms, we can save lives. I do not consider this position a privilege, but a test. I want to pass this test with honesty and commitment."He also addressed the issue of child stunting, stating that 38pc of children in Pakistan suffered from stunted growth, a condition that threatened their ability to play an active role in the country's future."Without investing in the health and nutrition of our children today, our dreams of national progress will remain unfulfilled," he added.
