Pakistan's IT workforce capable of competing in global market: PM

Islamabad(News Desk) Prime Minister Shehbaz Sharif on Monday said Pakistan's IT workforce had the capability to compete in the global market as information technology companies were being provided with necessary facilities to achieve their exports target of \$25 billion.His comments came during a meeting with a four-member delegation led by Jerome Kapelus, CEO of the US multinational IT company Afiniti that called on him, according to a press release by the PM's Office.

PM Shehbaz welcomed Afiniti's interest in further sector. He suggested that Afiniti Pakistan establish a world-class call centre in the country for national and international clients. He informed the meeting that he was personally overseeing programmes to equip the country's talented youth with IT, AI, and other advanced technical skills. Talking to the media on Monday, he added that to unlock its full potential, Pakistan needs international branding of its IT sector to ensure seamless

Acting chief justice of the IHC Sardar Muhammad Sarfraz Dogar will hear the petition, which has been filed under Section 24 of the Civil Procedure Code by SSP Abdul Ghafoor Anjum. The court was also requested that all pending cases and appeals against decided cases in this regard be heard by a single or larger bench of the IHC. The PTI has filed several petitions in the IHC regarding the jail facilities provided to Mr Khan, who has been in custody since his arrest in August 2023. KARACHI: (News Desk) The Grand Democratic Alliance on Sunday asked Pakistan Peoples Party chairman Bilawal Bhutto-Zardari to join the struggle against the construction of new canals on the Indus River from the platform of the opposition alliance if he genuinely opposed the controversial scheme.

The GDA and Pakistan Tehreek-i-Insaf (PTI) announced a joint candidate for the upcoming by-election in National Assembly constituency NA-213, Umerkot, where Lal Malahi will represent the united front in the by-polls. The polling will be held on April

Both sides reached the decision following a meeting of allied parties at Functional House on Sunday

The alliance vowed to mount a joint struggle against the controversial six canals on the Indus River.GDA and PTI to field joint candidate in Umerkot by-poll on NA seat, announces Sadruddin RashdiSyed Sadruddin Shah Rashdi, chief coordinator of GDA, while talking to journalists after the meeting, extended a public invitation to the PPP chairman, urging him to join their ongoing movement against the canals on Indus.He criticised the PPP leadership for its role in "striking deals" on Sindh's water. "The PPP chairman will not get any benefit from his father's dealings, but could gain much by joining the forces of the GDA and PTI.

KP will decide whether to expel Afghans after March 31


PESHAWAR:(News Desk) Pakhtunkhwa Khyber Chief Minister Ali Amin Gandapur on Sunday said his government would decide whether to follow the Centre's directives to expel province after March 31.

Afghans residing in the The federal government has asked Afghan Citizen Card holders to leave Pakistan voluntarily by March end, after which they'd be deported from the country.Mr Gandapur slammed the federal government's repatriation policy as 'inhumane and oppressive. "I am not in favour of Afghans' repatriation as per

the policy of the federal the chief government," minister said while talking to the media."When the deadline [March 31] will arrive," Mr Gandapur said he, as the chief executive of KP, would decide whether Afghans should be forcefully repatriated or not. "I will decide what suits me, suits the culture and traditions of KP," he said on the decision to expel Afghans. He said it was "wrong and inhuman" to forcefully send back Afghans without any arrangement for them in their country. The forced repatriation of Afghans at a time when they

had no facility in their country was a "violation of basic human rights".In reply to a question, CM Gandapur said the federal government had not contacted him on this issue, rather he was criticised when he suggested negotiations with Afghanistan though the federal government had earlier agreed with him on the issue of talks with Afghanistan. Rise in militancyEarlier, in a press conference, the chief minister said the state and its institutions were responsible for the surge in militancy.He alleged the state and its institution

have been "wasting their energies in dismantling and breaking the PTI and creating rifts in its leadership".The KP CM said the state and its institutions were not focusing on their prime duty of maintaining law and order and curbing militancy.It has resulted in the emergence of terrorism, he claimed."Today, I openly say that resurgence in militancy is the failure of the authorities at the helm of affairs and incompetency of the federal government and institutions," he remarked.He said the state and its institutions needed

FIA arrests suspect from Banigala for Jaffar Express attack 'anti-state campaign' on social media

Islamabad(News Desk) The Federal Investigation Agency (FIA) on Monday arrested a suspect from Bani Gala on the outskirts of Islamabad for his "anti-state campaign" on social media over the recent attack on the Jaffar Express train in Balochistan. The incident occurred on Tuesday afternoon when the train, travelling from Quetta to Peshawar and carrying 440 passengers, was ambushed by the Balochistan Liberation Army (BLA) terrorists. They opened fire on the train and held the passengers hostage, prompting the security forces to initiate an operation that lasted

On Wednesday evening, Inter-Services Public Relations (ISPR) Director General Lt Gen Ahmed Sharif Chaudhry confirmed that the operation had been concluded, with 33 terrorists present at the site of the attack neutralised. The ISPR chief also confirmed that 21 passengers and four Fron-

tier Corps personnel lost their lives in the hijacking, but no hostages were harmed during the final

rescue phase. According to a statement by an FIA spokesperson, the suspect was arrested during a raid in Bani Gala for "spreading hate campaign against state institutions".

TAXILA: (News Desk) Health department employees, including doctors, paramedics, nurses, lady health workers and clerical staff, staged protests in Attock against the Punjab government's decision to outsource basic health units (BHUs) and rural health centres

Scores of male and female employees of the health department including District Health Authority, Punjab Health Facilities Management Company (PFHMC), Integrated Reproductive, Maternal, Neonatal and Child Health (IRMCH), Prime Minister's Health Initiative Program (PMHI) took out a protest rally from Asfandyar Bukhari District Headquarters Hospital to deputy commissioner office against the privatisation. The employees staged a protest outside Kachhari Chowk and raised slogans against privatisation.

Speaking on the occasion, the protesters' leaders said that the Punjab government looked determined to carry out a "financial massacre" of health workers as it had decided to sell out the health sector at throw-away prices to the private sector.

They added that the grand health alliance had decided to thwart the government's bid to privatise the health sector. They pointed out that earlier the government had sold out many hospitals, labs and blood banks while many departments like radiology, security and correspondence were also being run by third parties. They claimed that the sanitation and security systems worsened in the hospitals and caused a nuisance for

Fazl plans protests against 'puppet govt' after Eid

ISLAMABAD: (News Desk) Jamiat Ulema-i-Islam-Fazl (JUI-F) chief Maulana Fazlur Rehman has announced plans to launch a nationwide protest campaign, along with the PTI, against the government after Eidul Fitr, citing rising corruption and deteriorating law and order in Balochistan and Khyber Pakhtunkhwa.

Speaking to media persons on Sunday, Maulana Fazl accused the federal government of neglecting security concerns in these provinces, claiming that the ruling coalition was least bothered about the

"We are planning to protest against the federal government's policies after Eidul Fitr, along with the PTI," he said.

A meeting of the JUI-F's general assembly had been called to devise a plan about the protest drive, he said, terming the current parliament and government "puppets".

While he acknowledged that PTI's real leadership remains in jail, he admitted that tensions between the two parties had subsided, paving the way for a possible alliance.

"Rhetoric by a few people will not cause a rift in the possible alliance with PTI. If certain individuals speak against me, PTI should take notice," he

A final decision on the matter, he added, would be made in JUI-F's policymaking meeting.

'State's existence in danger'Fazlur Rehman lashed out at the government's handling of security and governance, arguing that

authorities treat Punjab as if it were the entire country while ignoring Balochistan and Khyber Pakhtunkhwa.

"If there is no terrorism in Punjab, it does not mean that other provinces should be left to fend for themselves," he said, referring to the situation in Balochistan and the KP.

"The existence of the state is in danger and yet only the opposition parties are worried. Why is the government not thinking about it?" he questioned. "The prime minister is



inviting people for Iftar. Why can't they talk about the country's problems?" The JUI-F chief also questioned the government's legitimacy, stating that Prime Minister Shehbaz

Sharif, President Asif Ali Zardari and Interior Minister Mohsin Naqvi lacked electoral credibility and were not true representatives of peo-
