# 2 dead, 17 injured in blast near police vehicle in Quetta market

Quetta(News Desk) Two people were killed and 17 others injured after an explosion occurred near a police vehicle in the Barech Market area on Quetta's Double Road, officials said.

Confirming the deaths, Balochistan's health department spokesperson Dr Waseem Baig said, "The injured have been moved to the trauma centre at Civil Hospital." Civil Hospital Medical Superintendent Dr Abdul

Hadi Kakar told Dawn. com that the condition of four wounded people is critical.

Spokesperson Shahid Rind be heard in the backsaid in a statement that the explosion occurred near a police vehicle, adding that the nature of the blast was being determined.

Video footage circulating on social media, verified by Dawn.com, showed a crowd of people gathering at the scene of the blast, with the flaming wreckage of a motorcycle next to a charred police pickup truck. A damaged Suzuki Alto can also be seen in the frame.

A man was also seen pulling the burning wreckage of the motorcycle away from the vehicle in the Balochistan Government video, while sirens could

ground. No group has so far claimed responsibility for the blast.

Last week, a member of the Anti-Terrorist Force (ATF) was martyred and six others were injured three of them criticallywhen a roadside bomb targeted a police vehicle on Quetta's Brewery Road. The security situation in Balochistan has deteriorated over the last few months, with separatist militants frequently attacking police and armed

forces personnel. The outlawed Balochistan Liberation Army (BLA), in particular, has adopted new tactics to cause higher casualties and directly target Pakistani security forces.

Last year, the Interior Ministry noted a "significant rise in terrorism incidents and evolving terrorism patterns" since the Afghan Taliban seized control of Kabul in August 2021, especially in the Tehreek-i-Taliban Pakistan's activities in KP, the Baloch nationalist insurgency in Balochistan, and ethno-nationalist violence in Sindh. This is a developing story that is being updated as the situation evolves.

### Perturbed at delays, Imran moves IHC for early decisions

ISLAMABAD: (News Desk) Former Prime Minister Imran Khan has approached the Islamabad High Court (IHC) over repeated delays in cases against him, including the Toshakhana case, expressing concerns over the prolonged adjournments. His legal team, comprising Barrister Salman Safdar, Qausain Faisal Mufti and Ar shad Tabrez, filed a petition questioning the repeated postponements. They argued that hearings could not be cancelled without legal justification and that the accused must be present in court. The petition noted that the Toshakhana case, concerning allegations of unlawfully retaining and selling state gifts — including an expensive Bulgari jewellery set - was set to be heard at Adiala Jail but was unexpectedly moved to the Judicial Complex in Islamabad. The hearing was then adjourned until April 14 without any proceedings.

### Only drinking water available amid unprecedented shortage

SLAMABAD: (News Desk) With Kharif season startng in a few days, fears of an unprecedented water shortage are making it difficult for irrigation experts to plan water supplies for the entire season.

There is no water in dams, river flows have plunged and fewer snow deposits on mountains are not promising improved flows," an official told Dawn.

This will have very serious repercussions for crop output, he said. As a consequence, a meeting of the Advisory Committee of the Indus River System Authority (Irsa) decided on Wednesday to make only "drinking supplies" for one month, April, and then review the situation. This is a very rare event that water regulator has started water discharge parameters on a monthly basis, although past precedents are there for water allocations in three parts during a season.

The meeting noted that because of no storage in any of the three storages, water discharges at rim-stations stood at 51pc shortfall and went beyond 60pc while reaching provincial canal heads.

ISLAMABAD: (News Desk) The National Commission for Minorities Bill 2025 was under active review on Wednesday as the Senate Standing Committee on Human Rights subcommittee deliberated its key pro visions.



ISLAMABAD: (News Desk) The Auditor General's office on Wednesday raised alarm over the Higher Education Commission's failure to recover more than Rs1.5 billion from scholarship defaulters.

Calling it a critical matter, the issue was raised after audit officials reported that 5,321 students had received foreign scholarships under nine different projects.

While 96 individuals had defaulted, approximately Rs0.8 billion had already been recovered. The principal accounting officer of the Higher Education Commission (HEC), Ziaul Qayym, informed the committee that 36 cases were currently under trial.

This observation was made when the PAC convened under the chairmanship of MNA Junaid Akbar Khan to review audit objections concerning the Higher Education Commission (HEC). The members expressed concerns over scholars who had failed to return to Pakistan after completing their studies.

QAU VC tells apex committee demarcation issue with CDA remains unresolvedJunaid Akbar Khan urged authorities to file FIRs against them, while Senator Afnanullah Khan called the situation "shameful." Shahida Akhtar Ali questioned whether their passports could be revoked. In response, the committee chairman directed NADRA to cancel the passports and national identity cards of defaulters."This is a grave issue," remarked Shazia Marri, emphasising the need for stricter measures. Senator Khan suggested publicly naming and shaming the defaulters in newspapers.

### President, PM condemn killing of 5 passengers in Gwadar's Kalmat area

Islamabad(News Desk) President Asif Ali Zardari and Prime Minister Shehbaz Sharif on Thursday strongly condemned the overnight killing of five passengers in a firing incident in the Kalmat area of Balochistan's Gwadar district.Militants in Balochistan have recently intensified their attacks, with the

banned Balochistan Liberation Army (BLA) emerging as a key perpetrator of terrorist violence in Pakistan in 2024.Five people were killed by armed men who blocked the highway late last night, while three long-body trailers carrying urea from Gwadar port were set on fire in the Tajaban area, according to Highway Police Senior Superintendent of Police (SSP) Hafeez Baloch.Officials said four people were killed in the Kalmat area between Pasni and Ormara after being offloaded from a Karachi-bound passenger bus."Armed men killed four passengers after checking their ID cards and took away three others," an

official of the local administration said, adding that they belonged to Punjab. Security forces had moved towards the area where militants had blocked highways, with operations to clear the roads underway. The president and prime minister, in separate statements, prayed for peace for the departed souls.

## Council of Islamic Ideology comes out against SC verdict in polygamy case

ISLAMABAD: (News Desk) The Council of Islamic Ideology (CII) has ruled that the Supreme Court's decision related to polygamy is not valid as per the norms of Sharia. "It is un-Islamic to grant the first wife the right to annul the marriage as a result of solemnising second marriage [by her husband] without her permission," said the CII ruling.

The Council reached the decision at its 241st meeting presided over

by CII Chairman Dr Raghib Hussain Naeemi on March 25-26. The CII discussed the Oct 23, 2024 Supreme Court's decision, concerning a marriage dispute and the violation of Muslim Fam-
