PM Shehbaz announces Rs7.41 per unit cut in power tariffs for countrywide consumers

Islamabad(News Desk) Prime Minister Shehbaz Sharif on Thursday announced a Rs7.41 per unit cut in power rates across the country in a "major" relief package to reduce the burden on citizens facing exorbitant electricity bills. Speaking at an event in Islamabad, the premier congratulated the nation and said that it was not easy to convince the International Monetary Fund (IMF) of the cut, adding that his team had gone to great lengths to achieve the feat. For industries, he declared

that electricity prices would be cut by Rs7.59.The premier also emphasised that the government would have to take up structural reforms in the power sector, highlighting his determination to tackle the theft of Rs600 billion."Even though work on it has already started, we have to completely eradicate [malpractices]", he said. "If a shopkeeper is paying the electricity bill honestly and the shopkeeper next to him does not, then it is an unhealthy competition."The government on Wednesday

wrote on its official X account that "great news for the entire nation" would be unveiled today, without providing any details about the announcement itself. The post bore the hashtag 'Small Eid, Big Gift', referring to Eidul Fitr.It was widely reported last month that the prime minister would announce a Rs8 per unit reduction in electricity rates in his speech to the nation on March 23. The prime minister, however, did not announce any such relief package in his Pakistan Day speech.Instead, he

presided over a meeting on the power sector in light of a last-minute hiccup after a substantial reduction in electricity tariffs could not get past the Fund. The premier reiterated that a cut in electricity tariffs would "be announced soon".It may be noted that the government had decided to maintain the petroleum prices at the existing level — instead of an up-to-Rs13 per litre cut worked out by the oil regulator and the petroleum division - promising to transfer its financial impact to electricity consumers.



'Militant attacks in March surged to highest level since 2014³

ISLAMABAD: (News Desk) Militant violence and security operations intensified in the country in March 2025, with the number of militant attacks surpassing 100 for the first time since November 2014, according to a data released by the Pakistan Institute for Conflict and Security Studies (PICSS). The think tank reported 105 militant attacks during the month, resulting in 228 fatalities, including 73 security personnel, 67 civilians, and 88 militants. Additionally, 258 people were injured, comprising 129 security personnel and an equal number of civilians. Security forces also conducted intensified counter-militancy operations, resulting in the deaths of 107 individuals, including 83 militants, 13 security personnel, and 11 civilians, while 31 others were injured, among them nine security personnel and four militants.In total, militant attacks and security operations accounted for 335 deaths, with 86 security personnel, 78 civilians, and 171 militants among the deceased.

ISLAMABAD: (News Desk) Amid a deepening rift within the PTI's upper echelons, KP Chief Minister Ali Amin Gandapur held a meeting with jailed party founder Imran Khan, along with an aide, on Wednesday.

In a separate development that hints at the PTI's internal differences, the president of its Punjab chapter Hammad Azhar also resigned from his party position the same day.

During the Adiala meeting, Imran Khan reportedly asked CM Gandapur to re-engage with the es-

tablishment within the parameters of the Constitution and law, Adviser to CM Barrister Muhammad Ali Saif, who accompanied Mr Gandapur, claimed while talking after the huddle.

The meeting continued for two-and-a-half hours in the conference room of Adiala Jail. However, as per orders of the Islamabad High Court, they left without holding a media talk outside the jail.

Party sources said the meeting was a continuation of Tuesday's huddle between ex-minister Azam Swati and Mr Khan. On Tuesday, PTI leaders Advocate Salman Akram Raja and others reached Adiala Jail and Mr Raja provided to the authorities a list of persons who had to meet Imran Khan. However, Mr Raja was stopped from going inside while Mr Swati was allowed to meet Imran Khan. Jail sources claimed that Imran Khan was not willing to meet Mr Raja. Later, Mr Swati also claimed that the party founder was not willing to meet Mr Raja. Mr Swati said he assured Mr Khan

with the party and was

standing on principles. He also informed that based on his discussion with Mr Khan, some changes will be made in the KP government.

Party sources said that during the meeting between CM Gandapur and Imran Khan, various issues related to KP including political and security came under discussion.

Deportations begin today amid 'deadline extension' confusion

PESHAWAR: (News Desk) The second phase of sending back Afghan refugees is set to begin in earnest from today (Thursday) following the expiration of a government deadline for Afghan Citizen Card (ACC) holders to leave the country voluntarily. The government had set March 31 as the last date for ACC holders to return to their country and refused to budge despite calls from the international community to extend the deadline."Although the deadline was March 31, the provincial government extended it till April 2 keeping in view Eidul Fitr. Now, phase 2 will begin from [Thursday] and we have established camps, one each at Landi Kotal and Nasir Bagh Road," a senior official from Afghan Commissionerate in Peshawar. The two-day relaxation for Eid led to some confusion among official circles, with some sources suggesting that the deadline for repatriation had been extended. The AFP news agency reported the deadline has been extended until the beginning of next week due to Eid holidays, while the Associated Press claimed that arrests and deportations had been paused until April 10.

Under-trial prisoner found dead in Attock jail

TAXILA: (News Desk) An under-trial prisoner was found dead under mysterious circumstances in the lavatory of the Attock District Jail on Eid day. Prison officials claimed that the prisoner had committed suicide by hanging himself with a drawstring.

The inmate, identified as 37-year-old Rashid Khan a native of Bhallar Joggi village - was found by his fellow prisoners hanging from the window of the jail washroom.

They immediately informed the jail authorities about his death.

According to jail officials, Rashid was arrested by Hassanabdal police after registration of a first investigation report under section 354 of the Pakistan Penal Code on January 1, this year.

His case was under hearing at a local court in Hassanabdal. However, on Eid day, his body was found by his fellow prisoners hanging from the window of the iail washroom.

Jail authorities said the body was dispatched to the district headquarters hospital Attock for an autopsy. Afterwards, a judicial inquiry was carried out by civil Judge Syed Naseer Abbas in the jail in which statements of fellow inmates and jail officials were recorded. On the other hand, a teenage boy was killed, while a man was shot and injured in two separate accidents in various parts of Attock district on Wednesday.In the first accident, a 16-year-old boy identified as Ashsar Mansoor, a native of Chabb village, drowned in a water channel located on Makhad Road in Jand while taking a bath. A police spokesman said that a Rescue 1122 team retrieved his body and handed it over for burial.

2 arrested in Karachi for impersonating police, carrying out online robberies, kidnappings

Karachi(News Desk) Two people have been arrested in Karachi for impersonating the police and committing robberies and kidnappings via an online platform, it emerged on Thursday.

The suspects used to steal data from a private digital site and contact customers to receive deliveries, according to a press release by Karachi District East Police spokesperson.

"After contacting customers, the suspects would wear fake police uniforms and reach the doorsteps of the customers ti commit house robberies and kidnappings," the statement said.

Gulshan-e-Iqbal Station House Officer (SHO) Naeem Rajput arrested two of the suspects after identifying them through CCTV footage obtained from several crime scenes. Two illegal 30 bore pistols with ammunition, mobile phones, and stolen watches, among other items,
