Pakistan Mart to Rise in UAE: A Game-Changer for Pakistani


Exports Islamabad (News Desk): August 06, 2025 -In a major leap towards boosting Pakistani exports, a delegation from NLC and DP World, led by Director General NLC, met the Federal Minister for Commerce, Jam Kamal Khan. Also present were Mr. Fakhr Alam, Vice Chairman of DP World and CEO of the Pakistan Mart Project in the UAE, Rana Ihsaan Afzal, Coordinator to the Prime Minister, and Muhammad Ashraf, Executive Director General from the Ministry of Commerce. The delegation presented plans for "Pakistan Mart," a landmark commercial hub to be built near Jebel Ali, UAE, with DP World pledging to construct the project at zero cost for Pakistani stakeholders. The Mart will include warehouses, retail shops, showrooms, and e-commerce fulfillment centers, offering a one-stop marketplace to showcase Made-in-Pakistan products to regional and global buyers. Minister Jam Kamal Khan termed the initiative a "transformational project" for boosting exports, particularly in textiles, surgical instruments, sports goods, food, nutraceuticals. He also emphasized the need for e-commerce logistics solutions. The Ministry of Commerce, including TDAP, was directed to fully support the development. The Pakistan Mart is set to become a key step in export diversification and trade diplomacy in the Gulf.


Mohsin Naqvi Condemns Karak Terror Attack, Pays Tribute to Martyred FC Personnel

France Marks Youm-e-Istehsal, Denounces

Indian Actions in IIOJK France: (News Desk) – To express solidarity with the people of Indian Illegally Occupied Jammu and Kashmir (IIOJK), the Embassy of Pakistan in France organized a special event marking Youm-e-Istehsal, today. Messages of the President, Prime Minister and Foreign Minister of Pakistan were read out on the occasion, focusing on the origin of the Kashmir dispute, and the Indian suppression of the people of IIOJK. Speaking on the occasion, Ambassador Mumtaz Zahra Baloch said that six years ago, India took a set of illegal and unilateral actions on 5 August 2019 in IIOJK by scrapping IIOJK's special status and ending the last remaining semblance of autonomy. India took these measures consolidate IIOJK; its control undermining its internationally-recognized disputed status; and to convert Kashmiris into a dispossessed and disempowered minority in their own land. The Jammu & Kashmir dispute is our national cause and the main pillar of Pakistan's foreign policy. Pakistan will therefore continue to call upon the international community to hold India accountable for its crimes in IIOJK. Prominent speakers while condemning India's unilateral and illegal actions of 5 August 2019 as blatant violations of UNSC resolutions and international law demanded that the same must be reversed by the Indian Government. They denounced Indian efforts to alter the demographic composition of the occupied territory by issuance of domicile certificates to non-Kashmiris, introduction of new laws on ownership of land and redrawing electoral constituencies in IIOJK converting Kashmiris as a minority in their own land. A large number of people representing Pakistani diaspora, academics, journalists, students and professionals participated in the event that highlighted the seven decades long legitimate struggle of the Kashmiri people for their right to selfdetermination in accordance with the United Nations Security Council (UNSC) resolutions

Regional Ombudsman Holds Public Hearing In Sukkur, Resolves 90

on Jammu and Kashmir.

Cases

SUKKUR, (News Desk) Syed Mehmood Ali Shah, Regional Head of the Federal Ombudsman Secretariat Sukkur, presided over a public hearing on Wednesday under the Out-Reach Complaint Resolution program. A total of 90 cases involving Sui Southern Gas Company Limited (SSGCL) and Sukkur Electric Power Company (SEPCO) were addressed. Representatives from SSGCL's Regional Office in Larkana and SEPCO's Larkana office participated alongside the complainants, whose grievances were heard and resolved. The Ombudsman's office directed both agencies to strictly comply with the orders of Honorable Federal Ombudsman Aijaz Ahmed Qureshi, reinforcing its commitment to citizen grievance redressal and accountability. Notably, 32 cases related to SSGCL and 58 against SEPCO were resolved on the occasion.
